Re: Hastings Wellhead Protection Plan

Hazardous Waste

To Whom it May Concern:

The City of Hastings Wellhead Protection Plan was developed to ensure safe drinking water for the residents of Hastings. Protection of Hastings's drinking water is accomplished by managing the area that overlies the aquifers from which the City's wells draw their water. This management area is known as the Drinking Water Supply Management Area (DWSMA). One management activity under the Wellhead Protection Plan is to identify properties within the management area where hazardous wastes are generated.

You are receiving this letter because your property was identified during preparation of the Wellhead Protection Plan as a property where hazardous wastes are generated. As part of the City's efforts to ensure safe drinking water for the residents of Hastings, and as required by our Wellhead Protection Plan, we are notifying property owners located within the DWSMA for the purpose of raising awareness of resources and available assistance for hazardous management and reduction.

One of the ways in which you can help ensure safe drinking water for the residents of Hastings is to conduct a self-audit of your hazardous waste management and reduction practices. Conducting a self-audit will help you identify ways in which you can reduce hazardous waste and determine if you are properly managing your hazardous waste.
