## **November General Election Information**

The 2024 General Election will be held Tuesday, November 5. In addition to the presidential candidates, several other offices will be on the ballot, including Hastings municipal seats for City Council.

#### \*9/20 - Absentee voting begins.

**10/15 – Voter pre-registration deadline for the General Election.** The cutoff for pre-registration is 5:00 p.m. 21 days before any election. Drop voter registration applications off at the County Elections Office in Hastings. Voters can still register at the polls on election day.

#### \*10/18 – Early voting begins.

\* - Vote by absentee ballot or vote early at Hastings City Hall, the Dakota County Administration Building or one of the Dakota County service centers. Hastings City Hall has ballots for precincts within Hastings only. The Dakota County Administration Center and other Dakota County service centers have ballots for any precinct in the county.

# 11/5 – General Election. Polls will be open from 7:00 a.m. to 8:00 p.m. on Election Day. Vote at your local precinct polling location.

#### 2025 Budget Planning



Planning for the 2025 City Budget is underway. The City of Hastings values citizen participation in the budget process. See the budget process timeline below and view City Council documents for meeting times, agendas and packets at www.hastingsmn.gov.

The city's budget is structured to provide quality public services to residents and businesses. The budget process follows a timetable established by state law. The city uses an open and public process to adopt its annual budget. The process typically follows this timeline:

June - Departments prepare budget requests; City Council Workshop is held to discuss priorities

July - Department budgets reviewed by City Administrator

**August** - Finance Committee and City Council review budget requests

**September** - Council adopts preliminary budget and tax levy

**October** - Council reviews detailed preliminary budget at a public study session

**November -** Proposed property tax statements are mailed and list the dates of budget hearings of the taxing districts

**December** - Council reviews the budget at a public Truth in Taxation meeting and adopts final budget and tax levy

We welcome feedback and input at public meetings and workshops.

## **National Community Survey Results**

The city contracted with National Research Center/Polco to conduct the National Community Survey of residents earlier this spring. Nearly 9 out of 10 residents rated Hastings as an "excellent or good" place to live, with 8 out of 10 stating they would recommend living in Hastings to others and that they were planning to stay in the city.

Residents gave high marks to a variety of "livability" features that were above the national average, including availability of parks and trails and ability to travel by bicycle and car, ease of public parking, snow removal, historic/ cultural preservation, garbage collection, feeling safe from natural disasters, recycling and fitness opportunities.

Hastings scored lower than the national average in drinking water, a situation the city is working to address, and bus/transit services, which generally are not available in the city.

The highest ratings in 2024 were related to safety, recreational opportunities, elements of mobility, and improvements in the local business climate, such as opportunities for shopping. Resident ratings increased over the past three

years in areas related to Internet access, events, arts and cultural activities and attracting people from diverse backgrounds. The city's reputation improved 11 percentage points from the 2020 community survey.

Ratings in 2024 decreased in the areas of K-12 education, cost of living in Hastings, perceived value of services to taxes paid and animal control, but remained similar to other communities across the country.

"The City of Hastings overall ranks similarly with other cities on most questions. There are higher and lower areas this year, where we will want to get more information, so we can continue performing well in areas of importance and we can better serve our residents in areas where improvements are needed," said City Administrator Dan Wietecha.



## **Drinking Water and PFAS Update**



Hastings Drinking Water and PFAS



Hastings has PFAS contamination, also known as "forever chemicals," in our drinking water supply, exceeding maximum contaminant levels set by the US Environmental Protection Agency. Results from a feasibility study recommended construction of three decentralized water treatment plants for PFAS and Nitrate removal at a total estimated cost of \$68.9 million. The deadline for EPA compliance is April 2029; the city intends to build one water treatment plant per year 2026-2028.

Design work has started for water treatment plant 1 which is in the Industrial Park, a commercial site. This plant will likely be put out for bids in early 2025. Public Works has begun identifying several potential sites for treatment plants 2 and 3, which will be discussed by the City Council this summer. There is a strong preference to avoid residential neighborhoods.

City staff and council have held two work sessions to discuss potential water rate increases, phasing and timing. At present, we are looking at a rate increase around 35 to 40 percent. This would be the first of several increases coinciding with construction of each of the three water treatment plants. Please note that this would be on the water portion of the utility bill, not the entire bill.


The city has been exploring and pursuing multiple opportunities to offset the "budget buster" expense, including the following:

- Received a \$3.2 million grant from the Minnesota Pollution Control Agency for design of the three water treatment plants.
- Put forth a State Capital Budget request, but the session ended without a State Bonding Bill.
- Plan to again seek state funding in the 2025 legislative session.
- Submitted requests of Senator Klobuchar, Senator Smith and Representative Craig for federal support of the first phase of the project. At this point, it is in the House Appropriations Committee at a little over \$1 million, with Congressional decision expected late this year or into 2025.
- Submitted the first two phases for the State's Drinking Water Revolving Fund Intended Use Plan (IUP). Although the Drinking Water Revolving Fund is not our preferred funding source, it has the possibility of a \$3 million Emerging Contaminants Grant for each phase, which could be decided early this fall.

Over the past year and a half, we have worked with the MPCA on a series of environmental assessments, and MPCA has required 3M to conduct additional investigation. We believe the environmental studies have resulted in several lines of evidence of a connection of Well #5 to the 3M Cottage Grove site. We are discussing the implications of a connection with MPCA. In the meantime, we expect the environmental investigation for the other wells to continue.

## Understanding City Code Ordinance 95.06 Alarm System Permit



The City of Hastings supports the use of alarm systems to protect life and property. The city reminds all residents, business and building owners who have a monitored alarm system to register their alarm system with the Hastings Police Department, and to renew their registration annually by December 31st.

The purpose of Ordinance 95.06 Alarm System Permit is to ensure alarm systems are properly working; to reduce the number of false alarms which result in city services being used to respond to unnecessary alarms; and to provide added benefit to property owners by maintaining current information relating to alarm systems.



#### Bring Your Broken Items to a Fix-It Clinic for Free Repair Help



Dakota County residents can get help repairing household items, clothes, electronics and more at a Fix-It Clinic. These monthly events help keep items out of landfills and empower people to repair things on their own.

Show up to the upcoming Fix-It Clinic on Saturday, November 16 from 10 a.m. to 1 p.m. at Pleasant Hill Library in Hastings. The event is free and you do not need to register to participate.

Helpful volunteers will guide you through each step, from troubleshooting to a completed repair. Bring up to three items that need fixing or mending such as lamps, vacuum cleaners and clothes. ## **Development Initiatives To Spur Strategic Growth**



The City of Hastings took steps this past spring to drive strategic growth in housing, development and tourism in Hastings.

In May, the city approved a contract with Codametrics to overhaul the city's zoning code, which hasn't been revised in nearly 30 years. The current code is not aligned with what developers are seeking in several areas, including housing lot sizes, as one example.

Also in May, the Hastings Economic Development and Redevelopment Authority (HEDRA) approved its 2024-25 strategic plan, which outlines initiatives and timelines for the following:

- Development of underutilized sites, including block 28 off of Highway 61, between 4th and 5th streets, the Hastings Creamery and more
- Efforts to maintain the city's aging and naturally occurring affordable housing stock
- Continued funding for the facade improvement program and Makers
  Markets
- Development of a survey on the city's development and permitting processes
- Continued business retention and expansion visits
